Meat Business Women is a global network for professionals in the meat and food supply chain. We're building an inclusive, empowered community to attract and retain top talent, inspire women, and drive the industry forward through mentorship, connection, and transformative events.

ABOUT THE ONE TO WATCH AWARD

The "One to Watch" award celebrates the rising stars of the meat industry—young professionals who show exceptional promise, passion, and potential to lead and innovate in the sector.

This recognition aims to shine a spotlight on emerging talent, highlighting their contributions and inspiring others within the meat and food supply chain.

Eligibility:

- Open to individuals under the age of 35 as of 5th February 2025.
- Nominees must currently work in the meat and food supply chain industry in Australia.
- Self-nominations are the only option this year.
- Self-nominators must obtain their company's consent to participate.

Finalists will be selected based on their achievements, leadership, and vision for the future of the industry, with the winner announced at the Meat Business Women National Conference on 5th March 2025.

HOW TO SUBMIT YOUR APPLICATION

Follow these simple steps to create and submit your online application. Ensure your responses are clear, concise, and within the word limit to give yourself the best chance of being recognised.

STEP 1: GATHER YOUR INFORMATION

Before you begin, make sure you have the following details ready:

Employment History

• Dates of employment, roles, and companies you've worked for.

Entry Questions

Prepare answers to the following questions (250 words max per question):

- 1. Describe a specific project or initiative where you significantly impacted your organisation. What were the measurable outcomes?
- 2. Share a story of how you inspired or supported someone in their professional development.
- 3. Explain a major professional challenge you faced and the strategies used to overcome it.
- 4. In your view, what steps should the meat industry take to future proof itself?
- 5. What motivates you to work in the meat industry?

Consent Confirmation

Gain approval from your organisation for your nomination. You'll need to provide a reference (a manager or supervisor) with their:

- Name
- Job Title
- Company
- Email Address
- Phone Number

Uploads

- A recent headshot photo.
- Any supporting documents (optional).

STEP 2: COMPLETE THE ONLINE APPLICATION FORM

Visit the Meat Business Women website and navigate to the <u>One to Watch award</u> application page.

Fill in the following sections:

- Nominee Details
- Employment History
- Entry Questions
 - Write concise, impactful answers for each question. Keep them within 250 words.
- Consent Confirmation
 - Check the box confirming your organisation's consent.
 - Enter your reference's details.

STEP 3: REVIEW AND SUBMIT

- Double-check all your information and answers for accuracy.
- Agree to the Terms and Conditions of Entry by checking the box.
- Upload your photo and any optional supporting documents.
- Click "Submit."

Tips for a Strong Submission

Be specific and use measurable outcomes in your responses. Highlight your unique contributions and professional journey. Ensure your answers align with the scoring rubric provided.

KEY DATES

Launch and open nominations via website, 13th December 2024: email, and social media campaigns. Q&A webinar to clarify the nomination 16th January 2025: process for nominees. 5th February 2025: Deadline for submissions. Pre-screen nominations for completeness 6th-7th February 2025: and adherence to criteria. Judges review nominations and score 10th-13th February 2025: based on the rubric. Virtual finalist interviews conducted by the 17th-20th February judging panel. 2025: Judges finalise and submit their scores; 20th February 2025: winner is determined. Publicly announce the finalists on Meat 21st February 2025: Business Women's website, social media channels, and email newsletters. Announce and celebrate the winner at the 5th March 2025: Meat Business Women conference.

SCORING RUBRIC

UNDERSTANDING THE SCORING RUBRIC

The scoring rubric included in this pack outlines the criteria that will be used to evaluate your nomination for the 2025 "One to Watch" award. Each category reflects a key area of assessment, such as your impact, leadership, problem-solving skills, vision for the industry, and passion for the meat sector.

This tool is designed to help you understand how your submission will be scored, with clear descriptions for each performance level, from "Needs Improvement" to "Exceptional." Use this rubric as a guide to structure your responses and ensure your achievements and contributions align with the criteria.

By referencing the rubric while crafting your submission, you can highlight your strengths effectively and present a compelling case for why you are truly "One to Watch."

TERMS & CONDITIONS OF ENTRY

Eligibility Criteria:

- Nominees must be employed in the meat industry in Australia at the time of entry.
- Nominees must be under 35 years old and under as of 5th February 2025.
- Nominees must agree to participate in interviews and promotional activities.
- Nominees must obtain written consent from their organisation.

Submission Guidelines:

- All entries must be completed and submitted via the online form by 5th February 2025.
- Entries must adhere to the word limit for each question (250 words).
- Submissions do take time and effort. Expect your nomination to take up to two to three hours.
- Participants are encouraged to review the scoring rubric located on the Meat Business Women One to Watch webpage, that evaluates submissions across specific criteria, ensuring consistency and fairness.

Judging Process:

- All submissions undergo a thorough review process by our judging panel made up of representatives from across the meat and supply chain industry. Please refer to the One to Watch webpage for judging panel information.
- If a judge has a conflict of interest (defined as any situation where a judge has a personal or professional relationship with the nominee that could influence impartiality) with a submission, a representative from Meat Business Women will step in to review the nomination and conduct the virtual interview in their place.
- All submissions and interviews will be handled with the utmost confidentiality to protect nominees' information.
- Judging is based on the scoring rubric provided.
- Virtual interviews with finalists will contribute to the final decision.

Confidentiality:

 All submission information will remain confidential and used solely for the purpose of judging the award.

TERMS & CONDITIONS OF ENTRY

Prize:

The winner of the "One to Watch" award will receive funding of up to AUD \$5,000, which will be directly applied to support their personal and professional development. The funds must be used for one or more of the following:

- Accredited courses or certifications relevant to the meat and food supply chain.
- University or vocational training fees.
- Leadership development programs or workshops.
- · Professional coaching or mentorship sessions.
- Travel and accommodation costs for attending industry conferences or events.

Conditions:

- The winner must submit a development plan outlining how the funds will be utilised. Approval will be at the discretion of Meat Business Women.
- Funds will be paid directly to the education provider, event organizer, or service provider, rather than to the individual.
- The award must be used within 24 months of the announcement date, unless an extension is granted by Meat Business Women.
- Any unused portion of the fund will be forfeited.

Finalists and Winner Announcement:

- Finalists will be notified via email on 21st February 2025 and provided with details for their virtual interview, including timing and format.
- The finalists for the 2025 "One to Watch" Award will be announced on the Meat Business Women website, social media channels, and newsletter on 21st February 2025.
- Finalists are encouraged to attend the Meat Business Women National Conference on 5th March 2025 at Waters Edge, Portside Wharf, Brisbane, where the winner will be announced. Attendance will be at the finalist's own expense.
- Each finalist will receive a certificate of recognition, presented during the conference.

Disqualification:

• Incomplete, inaccurate, or late submissions will not be considered.
